Through a combination of innovative strategies, operational improvements, and investment in sustainable practices, our company has demonstrated a commendable commitment environmental, social and governance (ESG) issues and to being environmentally responsible. In one particularly key area, Cennox has made significant strides since starting our programme in 2023 in calculating and understanding greenhouse gas (GHG) emissions. This report aims to evaluate the effectiveness of Cennox's sustainability efforts and provide recommendations for future enhancements.


Sustainable Performance Evaluation:

Cennox Group Key Points and Reduction Targets:


- Cennox established ambitious GHG reduction targets in alignment with international standards such as the Paris Agreement. These targets provided a clear roadmap for the company's sustainability efforts.
- Target reduction in Greenhouse Gas Emissions by the maximum practicable rate, aligned with the United Nations Intergovernmental Panel on Climate Change recommendations to reduce emissions by 45% by 2030 with the aspiration of 100% by 2050. Net zero means cutting greenhouse gas emissions to as close to zero as possible, with any remaining emissions re-absorbed from the atmosphere, by oceans and forests for instance.
- Target energy reductions to identify and implement net present value positive energy conservation measures in our buildings, eventually providing 80% renewable energy across all regions with an aspiration of 100% renewable energy usage by 2050.
- Target reducing global waste 50% by 2040, with the aspirational goal of becoming a zero-waste business.
- Develop company-wide standards for utilising environmentally and socially preferred products, making environmentally and socially preferred products preferential in sourcing by 2030.
- Require all major vendors to report on progress in meeting Cennox standards and specified third-party environmental certifications and demonstrate their commitment to sustainability through corporate responsibility reporting by 2025.



GHG Data, Scope 1, 2 and 3 2023




GHG Data Transport 2023






GHG Data Purchased Heat & Electricity 2023

Emission Reduction Initiatives:

- Implemented energy efficiency measures across facilities, including increased use of timed/motion and LED lighting and energy-efficient equipment.
- Optimised transportation logistics to minimise emissions associated with product distribution and employee commuting (a continuous process).
- More meetings now online, minimising business travel.
- Centralised business travel scheduling in the US as a pilot programme, with global rollout planned.
- Engaged in waste reduction and recycling programmes to minimise emissions from waste disposal processes.

Technological Innovations:

 Reviewing and implementing technologies and automation to optimise processes and reduce energy consumption (e.g., heat pumps, smart HVAC vents, smart thermostats, automatic faucets and dryers, etc.).

Monitoring and Reporting:

- Implemented robust monitoring systems to track GHG emissions across operations accurately.
- Regularly reported emissions data to stakeholders, demonstrating transparency and accountability.
- Utilised data insights to identify areas for improvement and inform decision-making processes.
- With the new Diligent ESG Platform, we can now record GHG data across our facilities and vehicle fleet. Even in our first year we have a better understanding of where our footprint is affected and areas for improvement.

Collaboration and Partnerships:

- Collaborated with suppliers and partners to promote sustainability throughout the supply chain.
- Engaged with industry peers and stakeholders to share best practices and collectively address environmental challenges.
- Audited suppliers bi-annually to track sustainable performance.
- We now have the ability to track and audit our suppliers through our ESG Platform, enabling us to understand what metrics they have in place and whether or not suppliers are following our commitment to GHG reductions.

Strengths:

- Demonstrated strong leadership and commitment to sustainability.
- Implemented a comprehensive range of initiatives to reduce GHG emissions.



- Utilised data-driven approaches to monitor, analyse, and optimise performance.
- Fostered collaboration and partnerships to enhance sustainability efforts.

Areas for Improvement:

- Explore additional opportunities for renewable energy adoption.
- Enhance employee engagement and awareness regarding sustainability initiatives.

- GAP analyse to be completed on scope 1,2 and 3.

Recommendations:

- Continue to prioritise innovation and invest in emerging technologies to further reduce GHG emissions.

- Regularly review and update sustainability targets to ensure alignment with global climate objectives and industry best practices.

Sustainable Procurement

Environmental Impact:

- Setting specific environmental targets and incorporating them into supplier contracts.

Ethical Sourcing:

Ethical sourcing is another pressing concern for Cennox. The company sources various materials, including metals, plastics, and electronics, which can be linked to human rights abuses or unethical labour practices in the supply chain.



Recommendations include:

- Supplier audits and due diligence processes are being implemented to ensure ethical practices throughout the supply chain. In March 2024, our supplier questionnaire, which requires the upload of supporting documentation, goes live.
- Enhancing our code of conduct for suppliers, emphasising respect for human rights and labour standards.
- Collaborate with industry organisations and NGOs to stay informed about best practices and emerging issues in ethical sourcing.

Supply Chain Resilience:

Supply chain resilience is crucial for Cennox, as disruptions can lead to costly downtime and customer dissatisfaction. Sustainable procurement practices must consider supply chain risks, including geopolitical instability, natural disasters, and changing regulatory environments.

Recommendations include:

- Diversifying supplier sources to reduce dependence on a single region or supplier.
- Creating contingency plans for various supply chain disruptions and testing these plans regularly.
- Implementing real-time monitoring and data analysis to identify potential issues early.

Cost Efficiency:

Sustainable procurement can sometimes be perceived as cost-prohibitive, which may deter companies like Cennox from investing in eco-friendly and ethical practices. However, implementing sustainable procurement can lead to long-term cost savings.

Recommendations include:

- Conducting regular internal and external audits to assess and verify compliance.


